## *Our Projects and Activities*

### **1. Karnataka Child Rights Observatory**

It was initiated in 2008. CRT is the Secretariat to KCRO which has a membership base from all the districts of Karnataka (NGOs, academic institutions, media representatives and individuals). Since its inception in 2008, the initiative has been supported by UNICEF.



KCRO ran a programme under the title ‘Makkala Hakku - Sampanmoola Mathu Vakeeli’ (Child Rights Resources and Advocacy) with the objective of developing a civil society campaign on rights of children and young people in Karnataka.

2019 marked 30 years of UNCRC- the guiding spirit to protect the interests of the children. KCRO took the lead in organising a massive programme to commemorate the event with a series of initiatives. This included consultations at various levels, with children and NGOs, on the status of children; a publication, ‘Rocky Road to Realisation of Child Rights in Karnataka - a collection of Essay’ and a celebration of the event with fanfare in the midst of more than 150 children from across the state, and representatives from UNICEF, NGOs, Government and media.

District Child Rights Parliament, a concept initiated by KCRO, was conducted in 27 districts in collaboration with KCRO’s member organisations and the government. More than 2000 children participated and shared their issues with their government representative. Child representatives drawn from grama panchayat-level ‘Child Rights Grama Sabhas’ and then from the taluka-level ‘Child Rights Parliament’ take part in the district-level ‘Child Rights Parliaments’. They have drawn the attention of the administration on issues pertaining to health, nutrition, protection, education and participation.

KCRO also took the lead to initiate a review of the National Policy for Children, 2013 and to start working on the 'Alternate Report on the Implementation of UNCRC in India'.



Divisional level consultations were conducted to gather data and experiences from children and NGOs. Children led from the frontenacted their perception on various issues such as education, discrimination, health and nutrition, disability, rural and urban issues, financial position in families among others. The same was complemented by the adult members with data and case studies.

Discussions were held with the grassroots-level interveners during public hearing on child labour, child marriages, child trafficking, pre primary education. This was also done during pre election advocacy (Karnataka Assembly and Parliament elections). All these interactions have provided us with immense information, which helped prepare reports on the UNCRC, and also to recommend amendments to NPC 2013.

Monitoring of the child-centric legislative efforts have continued while having individual discussions with select legislators. They were also provided with questions and issues to be raised on the floor of the house. The regular publication, 'Are there children in Vidhana soudha?' has shown that child rights centric discussion-time and number of questions have come down (while the number of legislative debate dates have also dwindled) this year. The regular larger interaction through Karnataka Legislators' Forum for Child rights has not materialised owing to the political situation in the state. 'Are there children in Vidhana Soudha?'- a child centric audit of the proceedings of Legislative Assembly and Council.

We are now four years through the SDGs to be achieved by 2030. KCRO, along with its member organisations, made special efforts to understand the perspective of adolescents towards SDGs.

### **SDGs: Opinion of Adolescents**

India has around 47 crore children (2011 Census). Out of these, about 43% are adolescents (10-19 years). This group suffers from malnutrition and anaemia. There are innumerable



incidents of forced child marriages and trafficking. They are forced into labour, prostitution and other anti-social activities. There is an urgent need to protect and guide this crucial human resource group to achieve sustainable development. Against this backdrop, KCRO (Karnataka Child Rights Observatory) launched a Sustainable Development Goals campaign throughout the state to find the views/needs of adolescents on the Sustainable Development Goals. A special pamphlet was prepared for this purpose.

Before eliciting opinions from adolescents, in a workshop and orientation program, they were briefed on Sustainable Development Goals and SDGs identified by the UN. Their significance in today's world was explained at great length.

A total of 10,210 adolescents from 22 districts of the state participated in the poll. The number of boys was 5,163 and the number of girls was 5,047. The detailed analytical report is available in both Kannada and English.

## 2. RTE TaskForce - Karnataka

RTE Taskforce was initiated in 2011 as a movement to demand the implementation of RTE Act.



CRT also doubles up as the Secretariat for the movement and provides necessary technical know-how. It provides support to the various groups and individuals across the state who are interested in the implementation of RTE Act. We also initiated the discussion about the proposed National Education Policy Draft 2019.

The field programme of RTE Task Force at Shildlaghatta, Chikkaballapura Taluk worked with 55 primary schools and 50 Anganawadi centres to impart basics of RTE Act: implementation and skills, to improve the standards of basic amenities, quality of service delivery and education. This also included language learning and life skills, as well as career guidance. The programme has impacted the lives of 625 children in anganwadis and around 550 children in primary schools.

The RTE Task Force played a pivotal role in establishing *Balavikas Samithis*- School Child Rights Clubs and also in bringing a protocol to conduct Child Rights Grama Sabhas.



Although the RTE Act is about ten years old, the implementation of the Act seems to be lopsided with less attention to the details of the Act. One of the much publicised aspects of the Act is Sec. 12.1.c, which provides 25% reservation to children belonging to economically weaker sections in the non government schools at the entry level. Divergent opinions are given by the non-government schools, government and the law courts, resulting in a lot of confusion on the same. GoK in fact declared that non government schools are out of the discussion with respect to the implementation of Sec. 12.1.c. CRT and ERT (Education Rights Trust), which is also a networking organisation, jointly had approached the High Court to direct the Karnataka Govt to define the Sec. 12.1.c appropriately, which results in unaided schools staying out of the provisions of the Act. The High Court of Karnataka favoured GoK and we have approached the Supreme Court to intervene in the matter.

Career guidance sessions, based on the ‘Career Information’ module developed by the India Literacy Project, were organized in 20 High schools and in two PU Colleges for 1040 students. 135 parents were also invited to participate in these sessions. Twenty-one girls from families belonging to the economically weaker section were given scholarships to pursue pre-university education amounting to Rs1,92,000/- .

### ***3. Bengaluru ChildLine 1098***

CRT is the Nodal organisation for ChildLine 1098 Bengaluru operations since 2007. As the nodal, CRT continues to coordinate the advocacy and lobbying exercises with the Govt. It is also involved in



building capacities of the four ChildLine teams in Bengaluru. This is a project under ICPS, GOI.

As the nodal agency we advocated with the Education department and got a revised circular to make it mandatory for every educational institute to display 'ChildLine 1098' prominently in their premises. The circular also instructs institutions to give an opportunity to the ChildLine teams to create awareness among children on ChildLine 1098. As part of the awareness creation exercise on child protection, we organised 21 programmes in various institutions, public places, among practitioners who manage Child Care Institutions, resource organisations (hospitals, shelters, etc) and those NGOs who work directly with children.



In two major capacity building programmes of the team members, we oriented the team members of ChildLine on communications skills, effective public speaking and the preparations required for the same.

ChildLine 1098 got an opportunity to conduct a special programme on *Aakashvani* AIR on the need for child protection and introducing Childline 1098 to the listeners. We followed up with RadioActive Community Radio and conducted programmes on JJ Act, role of CWC and related issues. On the invitation of BBMP Special Commissioner (Education) we took a survey of dropouts from the BBMP schools, especially at 10th standard level to find out the reasons for the non attendance to schools and also skipping SSLC exams. Our recommendations to pay special attention and prevent them from dropping out has been accepted by the Commissioner.

In recent times a new police division has been carved out from within the existing one. We took the initiative to orient the police teams of this division on JJ Act provisions and related Acts while introducing the, to the child protection system that exists in the city. The orientation covered how to treat children in need of care and protection (CNCP) and also children in conflict with law (CIL). The good part is that the police now want more such programmes in the coming days.

ChildLine Nodal agency continues to provide awareness on child protection and about ChildLine 1098 in various schools and colleges and localities concentrating on local youth and associations. It is giving the expected dividends. A week-long programme under the title 'ChildLine Se Dosti' was conducted with a lot of fanfare to highlight the importance of child protection and to uphold rights of children.

#### ***4. IMAGE-Initiatives for Married Adolescent Girls' Empowerment)***

CRT is part of the larger consortium with six other organisations working in five different districts of Karnataka. The project was initiated in 2017 with the central focus on SRHR. While the field organisations are taking direct project interventions on the ground to prevent

child marriages and also to work with the married girls, CRT is the technical support group and also supports in advocacy and lobbying exercises.



Both the field interventions and the advocacy efforts are slowly yielding the expected results. With consistent follow up the



government has finally met the married adolescent girls on 9th Dec 2019, along with the members of the Committee appointed to study the status and situation of married adolescent girls. The Secretary to Department of Women and Child seems to be taking the issue further. Several rounds of training and workshops on communication, life skills and understanding the child marriages were conducted during the period with the field operators from all the five collaborating organisations.

Continued advocacy with the media has resulted in two editorials about child marriage issues in Prajavani, demanding the government take action to prevent child marriages and also provide services to married adolescent girls. Several other newspapers, both Kannada and English, as well as visual media have carried several stories to draw the attention of policy makers as well as the general public on the issues of married adolescent girls and thereby preventing child marriages.



## 5. GOOD – Getting Out of Devadasi System



As a new project GOOD was initiated in the beginning of Jan 2019 and has slowly evolved in the current year. In this project as well, CRT is the technical support, advocacy and lobbying organisation working as part of the consortium with five other NGOs in North Karnataka. The project originates from the SRHR concepts and specifically is addressing the issues of children of families who are either practicing the devadasi system, or were forced into sex trade. In the first year of the project cycle, staff capacity-building through training and workshops on legal issues, societal aspects, data collection-baseline, facilitation skills, life skills, skills for children as change agents was conducted. CRT has been instrumental in roping in the State Legal Services Authority for organising joint programs with DLSA in project area districts. CRT took the lead in organising a state-level media advocacy programme, joining hands with the Karnataka Women Journalists Association. The issues centered around dedication of children as Devadasi and the problems faced by children and women from Devadasi families were highlighted by various media.

By developing relationships with the KLSA we could get a circular reaching out to NGOs in the state to join DLSAs as para-legal volunteers. Several rounds of media orientation were conducted with the media personnel to highlight the plight of the families practicing devadasi system with a special focus on the educational and vocational education of the children.

In the coming years there would be advocacy activities centered around the Trafficking of Persons (prevention, protection and rehabilitation) Bill 1918 and strengthening DCPUs towards protecting the interests of the children.



Sustainable Menstrual Hygiene education is focused among girls, rural women reached and ensured adaptation of SMHM. The awareness sessions were organized in all the 20 schools that CRT is working with in Shidlaghatta taluk, covering 733 adolescent Girls, 36 teachers, 656 women from Self-Help Groups, 159 ASHA workers, 358 Anganvadi workers, 6 auxiliary-nurses and midwives. These orientations have helped girls understand physical changes, periods, the need for healthy management of menstruation and the proper way of disposing the used napkins. The SMHM programme has brought in adaptation and behavioural changes among 125 girls, 50 ASHAs, 52 AWWs, 10 teachers, 276 Community



women to switchover to use of cups and/or reusable cloth pads. 391 women have learnt about hygienic usage of traditional cloth pads during menstruation. The increased awareness in the community has led to the initiation of a cloth pad manufacturing unit - Raksha in Vantooru village. The team is producing around 250 reusable cloth pads per month.

### ***7. Rural Children's Libraries***


Chagaletti Rural children's library which continues to work with the local children and schools, has widened its reach. In its 9th year with the Pratham organisation a new initiative has been taken up to raise donations in the form of 'donate-a-book'. The idea is to start another set of 10 libraries in the near future.



Along with encouraging the children to read books, public speaking, painting and craft classes have been introduced during the reporting period.

## ***9. Child Rights Capacity building programmes, studies and reports, consultations with Govt and networking***

During this financial year, CRT organised various workshops, trainings and such other capacity building programmes in various parts of the state. We reached out to students, NGOs and government personnel from various departments in this endeavour. Through this we have found several new partners, and also strengthened our network and relationship with the old groups.

Currently CRT is the secretariat of CACL-K and has just initiated programmes for the year. CRT is also part of Network on Information for Parenting - Karnataka and IACR - India Alliance for Child Rights. We have taken part in various discussions that were centered around children and child rights. When the National Education Policy 2019 (draft) was released we had organised several rounds of discussion to understand the same. Alongside this, we have also been a part of the discussions pertaining to ECCD, disabilities, nutrition of children and mothers, Juvenile Justice Act, POCSO, etc.

### 12. Media and CRT

CRT regularly interacts with media representatives across the state on various child rights issues. Be it child marriage, child labour, devadasi system, prevention of child trafficking, girl child, rural children, migration, child abuse or other issues about various laws pertaining to children. We have been able to influence the media to write editorials on child rights issues and also nudges them to publish special articles relating to children in the newspapers periodically.

RadioActive CRT completed 52 episodes of Balya Amulya programme that detailed the various child rights issues regularly (weekly). The partnership is going very strong!



# 275 children escaped from govt-run homes in 4 years

## B'luru Tops The Table; All Are Boys

**Bengaluru:** The government on Friday admitted that 275 children escaped from state-run children's homes — Balamandiras — in the last four years. Karnataka has 60 such facilities.

Of the 275, 150 have been traced and brought back. This amounts to just 54% of those who chose the escape route. Usually, most of these children are either missing or homeless, found at bus stops and railway stations. They are given care and protection at these homes before being reunited with their families.

A look at the number, provided by the women and child welfare department and tabled at the legislative council suggests more boys than girls have slipped away from the Balamandiras. The report was tabled in response to a question raised by BJP MLC Mahantesh Kavathgimath.

Among those who escaped from these homes, the highest are from Bengaluru (55). Incidentally, the state capital has seen only boys leaving these homes since 2016. So far, none of them have been traced.

In Ballari, 25 boys escaped in the same period, of which 20 were found and brought back. Two girls too escaped and one was brought back in 2017-18.

Mysuru saw 27 boys escaping in the last four years, of which 20 were found. The district's girls home saw 19 inmates escaping, of which 15 were found.

According to Nagasimha G Rao, child rights activist, many kids found stranded in Bengaluru come from different linguistic backgrounds and they need to be spoken to in their language.

"Getting local language communicators is tough.

The story that the data on children's homes paints is obviously not a happy one. Children living in such facilities are already fragile at many levels, and more so psychologically. Picking them up from streets and bus stands is one thing. But giving them a second dwelling, which genuinely feels like home, is no easy task. Often, an alien space where they have to battle language barriers and live in the company of strangers can be overwhelming. These
